OFFER OF APPOINTMENT FOR PROJECT STAFF


Mr. / Ms. Sankar Maity is offered appointment as ~~Research Officer / Senior Research Fellow / Junior Research Fellow~~ on temporary basis under "SR/21/CY/039" Project at National Institute of Technology, Rourkela on a consolidated Remuneration/Assistantship of **INR 31,000/-** (1st & 2nd year) and **INR 35,000/-** for 3rd year only per month on the following terms and conditions: -

1. His/Her tenure of appointment is for the period of **3 years** (After completion of the project, the candidate enrolled for Ph.D. may receive fellowship upon satisfying institute regulations) or completion of the project, whichever is earlier.
2. He /She will work under the supervision of Principal Investigator and Academic Supervisor(s), who may be the same or different persons.
3. He/she will abide by the rules, regulations & discipline of the Institute.
4. He/She will sign the attendance register daily & submit monthly Progress Report along with the salary bill.
5. This appointment is on purely temporary basis and may be terminated at any time without any notice and without assigning any reason thereof and he/she will have no claim of appointment/absorption.
6. He/She will not be eligible for any leave and vacation other than Casual Leave and Holidays as admissible to the regular Institute employees.
7. He/She should join the Office **within a week (online)**, failing which the offer of the appointment will stand automatically cancelled.
8. Residential accommodation in the Campus or single accommodation in hostel against payment of approved charges may be provided as per Institute rule subject to availability, for which he will apply to PIC, House Allotment or Assistant Registrar (Academic) with a copy of this letter and the joining report. If on-campus accommodation is not available or not accepted, he will/will not be provided HRA at (As applicable) per month.
9. No TA is admissible at the time of joining or termination of the assignment.
10. He/She may enroll in the M.Tech(R)/PhD programme in the **Department of CY** subject to fulfillment eligibility criteria.
11. If you are enrolling in Ph.D., M.Tech (Res) or another academic programme, please bring the following:
 1. Original and one set of photocopies of qualifying degree certificate and mark sheet/grade sheet.
 2. Original certificate for proof of age.
 3. College leaving / transfer certificate in original.
 4. Relieving letter of sponsor, Identity Card / Salary Slip (in case of sponsored candidates).
 5. One Demand Draft or any mode of online transfer of Rs.56,500/- (Rs.47,000/- for SC/ST candidates) towards admission fee including mess advance in favour of Director, NIT Rourkela payable at SBI, NIT campus, Rourkela or the candidate can use online "Admission fee payment" portal of the institute for necessary payment as above.
 6. 3 passport size coloured photographs.

12. He/She should submit his/her joining report through the Principal Investigator in three copies in the prescribed form together with Medical Report in duplicate regarding his/her health and physical fitness for service from the Medical Officer of the Institute. The joining report in prescribed format may be forwarded by Principal Investigator and Head of the Department to the Assistant Registrar (Academic). On completing admission formalities including allotment of Hall of Residence in the academic section the candidate shall report to Assistant Registrar (SRICCE) for formal appointment and initialization of fellowship.
13. If the candidate after joining the project pursues postgraduate or research programme of this Institute, but leaves the project and thus abandons his/her studies before completion of the academic programme; he/she will be required to pay back to the Institute with interest the full amount of fellowship/stipend that he/she has received after admission.
14. Payment of Fellowship/Assistance ship/Remuneration is subject to availability of funds under the appropriate head of the project pursued by the Principal Investigator and may not be guaranteed in the event of unavailability of such fund as mentioned.
15. Only on confirmation of appointment by the Sponsoring Agency and receipt of funds, fellowship will be released.
